

Breaking barriers, increasing access Southeast

Limited access to healthcare and nearby options for healthy food are common problems in Southeast Fort Wayne. Cancer Services of Northeast Indiana is excited to be part of the momentum and concerted effort by local leaders to transform this area from a wellness desert into an oasis.

Cancer Services is debuting new programs and launching several partnerships to make it easy for people with cancer to access help and support.

“Our current Strategic Plan is focused on increasing the impact of our programs in underserved areas,” said Dianne May, Cancer Services President and CEO. “I’m proud of the strong partnerships we are developing and the progress we are making in eliminating barriers that prevent people from accessing services.”

The initiative has three components: Bringing Cancer Services programs to Southeast neighborhoods, building awareness about Cancer Services resources as well as general health and nutrition education and improving access to healthcare with transportation assistance.

Starting in October, Cancer Services will have wellness classes and a support group meeting in Southeast Fort Wayne. Many of these programs will be at The Impact Center located in the New Covenant Worship Center. The programs are open to Cancer Services’ clients as well as the whole community. A nutrition program and a support group are already scheduled. In the future, Cancer Services plans to offer exercise classes, such as Zumba, Tai Chi and FitStix.

In June, Cancer Services hired Health Educator Desirae Bledsoe to focus on developing programs that will be convenient for people living in the Southeast area of Fort Wayne (and nearby communities outside of Fort Wayne) and meet the specific needs of these people. Desirae will be holding educational programs on a variety of health-related topics – not all the classes will be related to cancer.

Finally, Cancer Services has partnered with HealthVisions Midwest of Fort Wayne and Community Transportation Network (CTN) to increase access to medical appointments. Cancer Services clients should reach out to their Client Advocate for more information.
